Acceleration of the UN0332 to UN3375 classification

NRCan needs to align with the global standard that Unsensitized Bulk Emulsions are classified as UN3375 and not UN0332. Ammonium nitrate emulsions that meet the requirements of Test Series 8, UN Manual of Tests and Criteria needs to be classified as a 5.1 Oxidizer. CEAEC members are willing to assemble a Team of qualified professionals to help develop the protocols that harmonize with the other global jurisdictions.

HIGHLIGHTS

Removal of regulatory overlap, MPU licensing

NRCan's MPU Licencing should focus on the process and not on the CMVSS components. Current requirements such as Centre of Gravity, Final Stage Document, and Incomplete Vehicle Documents should not be part of NRCan's review.
